3.	<input type="checkbox"/>	Must submit ALL <b><u>PASSPORTS</u></b> that you hold current/ old/ cancelled/ expired/ special)
4.	<input type="checkbox"/>	Family Book
5.	<input type="checkbox"/>	Vaccination Card.
6.	<input type="checkbox"/>	Health Insurance (Covered covid-19).
7.	<input type="checkbox"/>	Proof of property or rent contract and electronic or water bills is required.
8.	<input type="checkbox"/>	If the applicant owns a company, please provide a registration certificate of the company from your country's authorities, in which your name appears as the owner.
9.	<input type="checkbox"/>	If you are an employee in the company, please provide a valid official letter from your employer in English, stating your position in the company & salary and explaining the visit's purpose.
10.	<input type="checkbox"/>	For students, proof of a student from the school or university
11.	<input type="checkbox"/>	Last three months of bank statement, in which the name of the applicant appears clearly. With original bank stamp.
12.	<input type="checkbox"/>	In the case of a divorce, a letter from the court regarding in the custody of the child.
13.	<input type="checkbox"/>	Children under 18 must have parent's permission(original)and birth certificate.

### **IMPORTANT REMARKS**

1. Attach one set of photocopies of all the documents as mentioned above (Only A4 size and not in back to back format)
2. IN CASE OF MINOR: - [MINOR PROCESS](#)
  - a) Children under the age of 18 years must have parent's permission (no-objection) from the Police (original) & Birth Certificate.
  - b) In case one of the parents is not in country then he/ she should go to the Embassy of Jordan in the foreign country to issue no- objection for travel.
3. Embassy may ask for additional documents or request for personal appearance at the Embassy.
